## **COLA Hearing**

Upon a motion by Vincent R. Malgeri, seconded by Kevin A. Merz, the Board voted by roll call: Alan J. Benson, Yes; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; To open the public hearing to consider a Cost of Living Adjustment (COLA) for eligible retirees of the Essex Regional Retirement System.

### COLA of 3% Effective July 1, 2017

Acting Chair Yaskell noted that no one was in the audience to testify on the COLA increase. Mr. Kostro advised the Board that no comments pro or con had been received regarding the COLA. Mr. Benson stated his opposition to the COLA increase in light of the funded ratio of the retirement system and the challenge the retirement appropriation places on communities. Mr. Merz acknowledged the challenge faced by the communities but he also described his interaction with retirees and the importance to them of this annual increase. He pointed out that the 3% is on only part of the benefit and that our retirees actually fall behind those receiving Social Security over time. Mrs. Yaskell reiterated that this increase is only on the COLA base. Mr. Malgeri stated that this

increase is the least we can do for our retirees, who also face increases in medical costs and other items and that opposing this increase would join us with only one other retirement system in the state. Mrs. Yaskell asked Mr. Kostro what the average benefit is that is paid to retirees and he responded that it is \$20,000 annually. Mrs. Yaskell stated that she does not believe the unfunded liability should be balanced on the backs of the retirees. Mr. Maney said that he too understands the burden of the retirement appropriation on the communities but he noted the importance of the COLA to the retirees and he would be voting in favor of the increase. Upon a motion by Vincent R. Malgeri, seconded by Kevin A. Merz, the Board voted by roll call: Alan J. Benson, No; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; To approve a Cost of Living Adjustment (COLA) of 3% for eligible retirees of the Essex Regional Retirement System to be effective as of July 1, 2017.

The Board took a break at 9:06 a.m.

The Board returned to open session at 9:12 a.m.

# **Quarterly Investment Performance Report – Dahab Associates**

Seth Lynn from Dahab Associates reviewed the fourth quarter 2016 investment performance. He also reviewed the residual holdings remaining with State Street Bank, the former custodial bank, and how to address those. Mr. Lynn reviewed PRIT's fourth quarter performance and the emphasis placed on STRIPS investment and how that has performed over time. While the fourth quarter performance was not as good as the performance over the last few years, the margin between the upper tier performers and the lower tier in the fourth quarter is very narrow. Discussion ensued about whether an investment consultant can provide value to a system like ERRS that is going fully into the PRIT Fund. Mr. Maney spoke in favor of Dahab conducting an updated asset mix study and reporting back to the Board at the March meeting. Mr. Benson questioned whether there is any real difference between an investment strategy for the \$62 billion PRIT Fund and a local retirement board. He noted that the rules are all the same and that actuarial studies tend to have the same conclusions. Mr. Benson stated that he doesn't see where any tweaking of investment strategy would make any significant differences. The Board discussed the \$5,500 in STRIPS held at State Street and the \$212 in stock remaining with the custodial bank. Mr. Kostro stated that Eastern Bank has no account that these holdings can be moved to. Upon a motion by Alan J. Benson, seconded by Kevin A. Merz, the Board voted by roll call: Alan J. Benson, Yes; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; to provide authority to the Executive Director to dispose of the residual holdings remaining with State Street Bank as he, in his sole opinion, deems appropriate.

# **Principal Real Estate**

Vance Voss described the performance of the fund and the remaining assets in the fund, which may be distributed within the next year.

#### **Sentinel Real Estate**

Nick Stein reviewed the final amount remaining in the fund, which has been held back due to a tax issue. Upon resolution of the tax issue, the final distribution will take place. He expected the final distribution to take place in the first quarter of 2017.

# **Executive Director's Salary and Employment Agreement**

Mr. Malgeri reviewed the February 1<sup>st</sup> meeting with Mr. Maney and Mr. Kostro noting that the draft agreement was reviewed paragraph by paragraph and that he recommends that the Board approve the new agreement. Mr. Maney pointed out that the salary increases for the term of the contract were discussed and that Mr. Kostro volunteered to limit his salary increases to 1.5% annually. Mr. Maney said that they were prepared to go higher but that Mr. Kostro wanted to limit the effect of his salary on future budgets so that sufficient funds will always be available for increases for the other employees. Mr. Benson stated that did not understand why the length of the agreement was five years. Mr. Malgeri pointed to examples of other executive employment agreements that are five years in length. Mr. Malgeri also pointed out that many other employment agreements have set salaries as well, but at a higher rate, usually 2.5%. Mrs. Yaskell commented that she thought the salary increase rate set in the agreement was a bargain for the retirement system. Mr. Malgeri also noted that he and Mr. Maney believe ERRS has a very effective Executive Director and they want to retain him. Mr. Benson then asked if termination without cause was considered. Mr. Malgeri pointed out that clauses permitting termination without cause almost always include a severance payment and that there is no severance package in the proposed agreement for Mr. Kostro. Mr. Maney noted that Mr. Kostro has been with the Board for six years now and the Board knows the relationship it has with the Executive Director. He did not believe, therefore, that termination without cause was an issue. Discussion ensued that the Board has never provided a severance package in any of the Executive Director's employment agreements. Mr. Benson stated that he understands based on how things have gone with Mr. Kostro since he was hired that termination without cause is not really an issue. However, he reiterated his opposition to setting the salary for the term of the agreement and to a five year agreement. Mr. Merz indicated his support for the agreement as drafted. Mrs. Yaskell also stated her support for the agreement as drafted.
