ERRS Board Acting Chairman Susan J. Yaskell called the meeting to order at 8:30 a.m. The Board said the pledge of allegiance.

Opening Statement by the Chair - Recording of the Meeting

The Massachusetts Open Meeting Law permits meetings to be recorded and states that the Chair shall inform attendees at the beginning of the meeting of any such recording. Therefore, I am informing everyone attending this meeting that Jane Dooley, the Board Secretary, is recording this meeting.

Remote Participation Announcement

From the Acting Chair Susan J. Yaskell: Pursuant to 940 CMR 29.10, the Chair is advising the meeting that Joseph Maney will be participating in this meeting remotely as permitted under Section (5) as geographic distance makes his attendance unreasonably difficult.

I would also note for the record that a quorum of the Board is present at the meeting as required and that Mr. Maney is participating via telephone and Skype and that he is clearly audible to everyone present.

Also, I would note as well that I will be chairing this meeting as required by the Remote Participation Regulation.

Finally, I want to remind the Board and those in attendance that all votes at a meeting in which a member participates remotely shall be by roll call.

Cost of Living Adjustment Public Hearing

Upon a motion by Kevin A. Merz, seconded by Vincent R. Malgeri, the Board voted by roll call: Kevin A. Merz, yes, Alan J. Benson, yes, Susan J. Yaskell, yes, Vincent R. Malgeri, yes, H. Joseph Maney, yes, to open the public hearing to consider a Cost of Living Adjustment (COLA) of up to 3% to eligible retirees of the Essex Regional Retirement System to be effective as of July 1, 2016.

Malgeri and Maney both expressed support for the increase. Benson explained that ERRS is working toward full funding by 2035 and is at 50% now. He noted that 7% to 8% annual increase is what is occurring for assessments to the member communities. Benson suggested that expectations need to change including 3% COLA increase in annual funding plan which is costing millions of dollars in overall unfunded liability. He thought ERRS was not in a position to vote for the increase. Merz viewed the COLA base as the issue every year which is at \$13,000 and gave the example of a retiree receiving \$39,000 a year with the 3% annual COLA increase this gives the retiree a 1% increase on his/her pension and is not enough to keep up with inflation. He added that many retirees are not able to get Social Security and ERRS should do what it can to create a similar standard of living for retirees. Yaskell noted that some retirees are receiving \$17,000 a year for pension and she thought the retirees deserved the 3% increase.

Public Comment

George Howe, retiree and former Ipswich town manager, was in attendance and stated how the 3% was appreciated every year and expressed interest in Board support for the COLA increase.

Seth Lynn from Dahab Associates noted that the draft policy was one of the best he has seen. The policy includes investment objective and asset allocation relative to ERRS working toward moving all assets into the PRIT fund where PRIM has its own investment policy. The PERAC auditors have asked ERRS for its investment policy.

Dahab Associates – Authorization for Custodial Bank Procurement Investment Policy

State Street Bank has been the custodial bank for ERRS. PERAC views that custodial bank contracts should be limited from five to seven years. The State Street Bank contract is up this year and these custodial services need to be procured. There is a recommendation for Dahab Associates to manage the procurement for provision of custodial bank services for \$12,000.

The expected response to this RFP is about six banks, and an asset base fee would be built in (i.e., 2 basis points on net asset value) so this is where increases would occur. ERRS does not have much active equity with so many assets in the PRIT fund so it is unlikely fees on PRIT assets would be incurred. ERRS has paid State Street Bank

\$60,000 in the last few years. Distributions from ERRS's private fund managers go to short term cash fund. The balance ERRS keeps at State Street Bank is \$1 million to pay its bills. Kostro and Finance Director Ann Speicher have met with State Street Bank. Discussion addressed if a bidding bank would present a fee schedule (i.e., flat fee for 5 years).

Discussion was on flat fee arrangement with Dahab Associates due to how much of ERRS's assets are in the PRIT fund, and work hours that the consultant expects will be required for the custodial bank procurement process for \$12,000 especially relative to due diligence for PERAC. The consultant will review and rank the bid proposals for the Board assessment. Kostro stated that he was comfortable bringing the authorization for custodial bank procurement forward for Dahab Associates.

Upon a motion by Vincent R. Malgeri, seconded by Kevin A. Merz, the Board voted by roll call: Kevin A. Merz, yes, Alan J. Benson, no, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, that pursuant to Section III of the agreement between Dahab Associates and ERRS, the Board does hereby authorize and direct Dahab Associates to conduct a procurement for the provision of custodial bank services in accordance with the requirements of Chapter 176 of the Acts of 2011, and that the fee for this service shall not exceed \$12,000.

Annual Investment Manager Meetings:

Dahab Associates - Q4 2015 Investment Performance Report

Dahab Associates presented the Q4 2015 investment performance report with large cap growth stocks the strength in the market. Also, that PRIT global equity is up over 5%. Although the bond market and fixed income drew down returns. PRIT fund did well in public market not as well with hedge fund and private equity. ERRS did well with its private real estate and private equity investments. Dahab Associates will investigate information relative to PRIT's exposure to fossil fuel and report to Board.

Principal Global Advisors Fund

Vance Voss reported on assets sold, and 15.1% return on investment for fund. The end of fund life is projected for August 2016.

Sentinel Real Estate Fund IV

Bob Bartlett described how the fund is being wound down with all direct investments sold. One of two remaining investments will be sold. Next month ERRS will receive \$75,000. The final property will be sold and fund closed in May. The fund had an overall 11% return. ERRS invested \$1 million and reinvested \$2 million. Distributions have been \$3 million and \$1 million is left in the fund. Income from fund for life of fund was 6%.

The Board took a break at 10:11 a.m. and the meeting was reconvened at 10:24 a.m.

Release of Executive Session Minutes

ERRS General Counsel Michael Sacco summarized that Attorney Tom Fallon had requested exhibits from Peter Nikas case with appropriate redactions. Attorney Fallon is advancing an argument (alleged bias) in court about Sacco acting as ERRS counsel and hearing officer and would us the exhibits to prepare his case. ERRS usually releases any minutes on a quarterly basis.

The annual legal budget for Sacco has been \$75,000 and Murphy, Hesse, Toomey and Lehane is \$10,000 to \$15,000. A prior reserve fund transfer has already occurred to Murphy, Hesse, Toomey and Lehane. There is \$25,000 left in the reserve fund.
