Larry Stone, Stone Consulting, Inc.:

2016 Valuation Study

Actuary Larry Stone reviewed assumptions, methods and preliminary results associated with January 1, 2016 Actuarial Valuation for ERRS. He reported on investment returns, Essex Agricultural School scenario, asset smoothing, and market value of assets, generational mortality assumptions, and select/ultimate salary information.

The Board discussed and agreed to a funding schedule of 18 years with first five years of 7.5% increases followed by 4% increases to reach full funding by 2035, also including \$14,000 COLA base, generational mortality and 7.75% discount rate, to present at the upcoming Advisory Council meeting.

"Free" Creditable Service Allocations - Lawrence Retirement Board Decision

The Board discussed Lawrence court case where an employee can get free service when a member unit joins a retirement system. This was done with ERRS with Manchester-Essex (20 people) and Rowley Housing Authority (1 person). Part of the statute states that the employer can be billed to recoup cost of service rather than through the employees. Stone will determine allocation that would be added to the funding schedule for Manchester-Essex and Rowley.

Refund Warrant

Malgeri, the Board voted: 4-0 to approve the warrant for September 2016, to refund, rollover and transfer the total accumulated deductions for thirty-one members beginning with Eric J. Military Service Purchases

Upon a motion by Susan J. Yaskell, seconded by Vincent R. Malgeri, the Board voted: 4-0 that the retirement system shall notify members who indicate that they are a veteran on their enrollment form that they may be eligible to purchase up to four years of military

service and that such notification be sent to the member as soon as practicable after their enrollment.

There is a 180 day window when veterans can send in an application to purchase military service after being enrolled in the retirement system. The ERRS personnel will contact members who indicate they are veterans on their enrollment form.

Election Update

ERRS received two nominations for the third and fourth member positions on the Board for the two Board incumbents. So ERRS will notify Advisory Council that the two incumbents have been elected to the Board. The election will not be held saving ERRS money and retirement system employee time. PERAC was informed about this decision which complies with the statute.

Revised 2017 Preliminary Budget

The preliminary 2017 budget is going to the Advisory Council with one change in employee salary added at the last meeting.

Policy Memo #16-27 – Regular Compensation Policy

Upon a motion by Vincent R. Malgeri, seconded by Susan J. Yaskell, the Board voted: 3-0-1 with Kevin A. Merz abstaining, that Policy Memo #16-27 defining regular compensation for members who hold positions in addition to the position that qualifies them for membership is approved as described below:

"The purpose of this policy is to clarify what constitutes regular compensation as it relates to certain wages earned by members of the retirement system. This policy applies only to wages earned in a position that is in addition to the position which qualifies the individual for membership (hereinafter referred to as the "second position".)

Further, this policy defines whether wages earned by members who are also employed as reserve or intermittent police officers and call firefighters qualify as regular compensation.

This policy does not apply to wages earned by elected officials, which are governed by statute.

Wages paid to a member who is performing duties for any employer within the retirement system in a second position may be considered as regular compensation, even if the second position, in and of itself, would not qualify the individual for membership.

In order to be considered regular compensation, however, the payments made to a member in a second position must be regular, recurring and predictable. For instance, the second position must have a set schedule.

Further, in order for payments made to the member to be considered regular compensation, the second position must be a permanent assignment, meaning that there is no predetermined end date, unless such end date shall be established by law.

Overtime wages, whether paid to a member for their primary position or for their second position, are never regular compensation. No wage paid as overtime, or any portion of such overtime wage, may be considered as regular compensation.

Wages paid to reserve or intermittent police officers and call firefighters who are paid on a per call basis and who do not have a permanent schedule of indefinite duration are not considered regular compensation.

The Board of the retirement system recognizes that the definition of regular compensation has been evolving since the passage of Chapter 21 of the Acts of 2009 ("Pension Reform") and that this policy may prohibit practices previously permitted. Therefore, any active or inactive member of the Essex Regional Retirement System whose wages are no longer considered regular compensation pursuant to this policy, will receive a refund of any deductions withheld from such wages dating from the July 1, 2009 effective date of the Pension Reform Act. Any such refund will be considered a return of erroneous deductions and will be refunded directly to the member subject to the required 20% withholding of federal tax."

Policy Memo #16-28 – Disability Applications Policy

Upon a motion by Vincent R. Malgeri, seconded by Susan J. Yaskell, the Board voted: 4-0 that Policy Memo #16-28 relative to communications with members who have filed an application for disability retirement is approved as described below:

"Upon receipt of an application for a disability retirement, all communications from the retirement board pursuant to the application will be communicated directly to the member.

If the member has retained an attorney, the attorney should file with the retirement board a notice of appearance, a copy which shall be sent to the member. Upon receipt of the notice of appearance, the retirement board will copy the member's attorney on all correspondence sent to the member.

All medical records submitted in support of a member's application for a disability retirement shall be independently obtained by the retirement board. Any medical records submitted directly by the member or the member's representative, will be returned.

Any charge for the production of medical records provided in support of an application for disability retirement shall be borne by the member."

Determination Regarding the Prior Board's Acceptance of Liability

The prior Board did not deny liability. ERRS recognizes this and will not contest prior practice. It is contesting PERAC's calculation of liability being assessed in 3(8)(c) bills relative to the prior Board.

The Board took a break at 10:00 a.m. and reconvened at 10:10 a.m.

Upon a motion by Vincent R. Malgeri, seconded by Kevin A. Merz, the Board voted by roll call: Kevin A. Merz, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, to move to executive session at 10:10 a.m. to act on the disability applications of Ralph Matthes and Kim DiOrio-McGonnell and to remain in executive session to discuss strategy with respect to litigation as an open meeting may have a detrimental effect on the litigating position of the retirement system.
