ERRS Board Acting Chair Susan J. Yaskell called the meeting to order at 8:36 a.m. The Board said the pledge of allegiance.

Opening Statement by the Acting Chair - Recording of the Meeting

Susan J. Yaskell, acting as the Chair, read the following statement: The Massachusetts Open Meeting Law permits meetings to be recorded and states that the Chair shall inform attendees at the beginning of the meeting of any such recording. Therefore, I am informing everyone attending this meeting that Pamela Lynch is recording this meeting.

Remote Participation Announcement

Susan J. Yaskell, acting as the Chair, read the following announcement: Pursuant to 940 CMR 29.10, the Chair is advising the meeting that Joseph Maney will be participating in this meeting remotely as permitted under Section (5) as geographic distance makes his attendance unreasonably difficult. I would also note for the record that a quorum of the Board is present at the meeting as required and that Mr. Maney will be participating via Skype and that he is clearly audible to everyone present.

In Mr. Maney's absence, I will be chairing this meeting as required by the Remote Participation Regulation. Finally, I want to remind the Board and those in attendance that all votes at a meeting in which a member participates remotely shall be by roll call.

Administrative Assistant Stipend

Merz, the Board moved to amend the position description for the Administrative Assistant to add a monthly stipend of \$100.00 for the performance of public meeting support duties. Mr. Kostro reviewed the effort's to hire a new Board Secretary, including posting the position at the wage previously paid, which the Board rejected, and then posting the position at the reduced wage, which produced no qualified candidates. He described efforts to recruit individuals for this position at the reduced wage and directed the Board's attention to the letter in their packet from a municipal Board Secretary who turned down the ERRS position as the wage was too low. Mr. Kostro noted that the ERRS administrative assistant attends the monthly meetings now to support him and that the proposed stipend of \$100 reflects the additional duties she is being assigned which were not in her original job description. He noted that this payment still results in a savings of \$2,000 compared to what was budgeted for the Board Secretary and that PERAC does not see any issue with paying this stipend. Mr. Benson noted that this is not how they adjust job descriptions in Boxford. Ms. Yaskell suggested returning to this item once the Skype connection with Mr. Maney was properly working.

Membership Regulation

Mr. Kostro reviewed for the Board the next three agenda items, as he felt they were all related. He described the desire of the staff to establish a set series of rules which govern who is eligible for membership, how they earn service and what qualifies as regular compensation. Mr. Kostro said that the membership regulation was fairly straightforward and that the new regulation will bring the retirement system into compliance with the recent DeFelice decision which established that "once a member, always a member" is now the law of the land. He noted that the requirement for continuing membership was removed but a clarifying paragraph was added stating that an employee had to earn twenty hours per week of regular compensation in order to be eligible for membership.

Mr. Kostro reviewed the proposed rescission of the 2014 amendment to the creditable service regulation in which a member who fell below twenty hours per week was not eligible to earn creditable service. Since "once a member, always a member" keeps the

members in the retirement system and requires that the members make contributions, ERRS did not want to take deductions from a member but give them nothing in return. This proposed motion eliminates that requirement.

Mr. Kostro then reviewed the proposed new amendment to the creditable service regulation which requires that a member who no longer works twenty hours per week has all of their service of less than twenty hours per week, prorated. He said that the staff has spent significant time reviewing how this would work and how it could be tracked. In his opinion, the only way to prorate service for someone in this situation is to do it at the conclusion of their service. He noted that the retirement system has tried to keep member's creditable service up-to-date on an on-going basis so that they know what their benefit will be. He reminded the Board of cases where members had service issues that were not reflected on their account until they applied for a retirement, only to have the member find that they actually had less service than they thought, thus lowering their benefit. Mr. Kostro mentioned that it was the staff's strong recommendation that this proposed amendment be passed over and that a member's service which is below twenty hours be considered full credit, provided that they were always part-time.

Mr. Kostro then reviewed the issue of what qualifies as regular compensation. He pointed to PERAC's letter from 2015 in response to a complaint from the Town of Hamilton, which led to the elimination of certain wages for second positions being qualified as regular compensation. Mr. Kostro also reviewed the history of the prior Board admitting into membership individuals who did not meet the membership requirements at the time. He said that members who were made inactive under the old membership policy will now be active members under the "once a member, always a member" policy. However, their wages do not meet the standard to be considered regular compensation. His memo was to clarify what qualifies as regular compensation for members who only have a single position.

ERRS Counsel, Michael Sacco reviewed issues surrounding regular compensation as it is applied to call firefighters. Mr. Sacco suggested that a paragraph be added to the members annual statements notifying them that if they had a schedule that fell below twenty hours than that service will be prorated.

Board members suggested other opportunities to provide notice to members that their service may be prorated. Mr. Benson reviewed scenarios in which the proration of service would affect a member. He cited a recent example of a Boxford employee who spoke with him regarding call firefighter wages. He asked if this member resigned his primary job and had only the call firefighter position, would he be able to contribute to the retirement system? Mr. Sacco answered, no, the call firefighter wages would not qualify as regular compensation.

Mr. Kostro reminded the Board that the policy approved last year on regular compensation for second positions had a refund date of July 1, 2009. He noted that this has had an unintended effect on some members who have call firefighter or reserve police

wages and who were close to retirement. He said he did not know if the Board wanted to or not, but it could change the refund date of the policy from July 1, 2009 to date the policy went into effect in 2016, which would then mitigate the effect of this policy on those members who were close to retirement. No motion was made to make this suggested change.

Membership Regulation

Upon a motion by Vincent R. Malgeri, seconded by Kevin A. Merz, the Board voted by roll call: Alan J. Benson, Yes; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; To submit to PERAC for approval a new membership regulation which states as follows:

Any individual who is permanently employed twenty (20) or more hours per week by a single member unit of the Essex Regional Retirement System ("System") and who receives at least \$5,000 in wages as defined in M.G.L. c. 32, § 1 and 840 CMR 15.03 shall become a member of the System.

For the purpose of this regulation, "permanently employed 20 hours per week" shall mean that the employee is guaranteed 20 hours of weekly compensation each and every week.

Any elected official who earns at least \$5,000 in wages may elect to become a member of the System within ninety days after the date of assuming office.

Creditable Service Regulation - Rescind

Upon a motion by Alan J. Benson, seconded by Vincent R. Malgeri, the Board voted by roll call: Alan J. Benson, Yes; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; To remove the following amendment approved on August 13, 2014 from the creditable service regulation, subject to approval by PERAC:

Any member in service who is not permanently employed, either by contract or written or oral agreement, at least 20 hours per week and earning at least \$5,000 in regular compensation per year will not receive any creditable service.

Creditable Service Regulation - Amend

Prior to the vote, Mr. Kostro stated that if the staff had a vote they would ask the Board to pass over this item. Upon a motion by Alan J. Benson, seconded by Kevin A. Merz, the Board voted by roll call: Alan J. Benson, Yes; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; To submit to PERAC for approval the following amendment to the creditable service regulation:

Any member in service, whose status is changed so that they are employed less than 20 hours per week, but who continues to receive at least \$5,000 in regular compensation per year as defined in M.G.L. c. 32, § 1 and 840 CMR 15.03, shall receive prorated credit based on the full-time equivalency of 150 hours being the

equivalent of one (1) month of service. Such proration shall be effective as of the date upon which the member was no longer permanently employed at least 20 hours per week. Any member who returns to being permanently employed at least 20 hours per week shall receive service credit pursuant to the creditable service regulation of the retirement system.

Regular Compensation - Base Compensation

Upon a motion by Alan J. Benson, seconded by Vincent R. Malgeri, the Board voted by roll call: Alan J. Benson, Yes; H. Joseph Maney, Yes; Vincent R. Malgeri, Yes; Kevin A. Merz, Yes; and Susan J. Yaskell, Yes; That the memo from the Executive Director to ERRS staff defining what constitutes regular compensation is approved as amended.

Mr. Benson mentioned that he understands Mr. Kostro's concern about the creditable service regulation and the proration of service and, after a year, if Mr. Kostro needs to come back and have this played with a little, he understands the administrative challenge of this regulation.

The Board took a break at 9:43 a.m.

The Board returned to open session at 9:50 a.m.

Executive Session

Ms. Yaskell advised that the Board will return to open session upon the conclusion of the executive session only for the purpose of adjourning the meeting.

The Board moved into executive session at 9:50 a.m.
