Executive Session – Litigation

Upon a motion by Kevin A. Merz, seconded by Vincent R. Malgeri, the Board voted 5-0 at 8:50 a.m. by roll call vote: Kevin A. Merz, yes, Ira S. Singer, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, to move to executive session to discuss strategy with respect to litigation as an open meeting may have a detrimental effect on the litigating position of the retirement system. Kevin A. Merz amended the motion noting that the Board would return to open session from the executive session. Vincent R. Malgeri seconded the motion. The Board voted 5-0 by roll call vote: Kevin A. Merz, yes, Ira S. Singer, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, to approve the amended motion.

The Board returned to open session from executive session at 9:16 a.m.

COLA Base Discussion

Discussion ensued about 30 day notice to Advisory Council before hearing that would be scheduled at Board's February meeting on COLA percentage increase and if COLA base would be increased from \$13,000 to \$14,000. The Advisory Council has to vote on any proposed increases by the Board. ERRS has information on what other retirement systems are doing with COLA and base as well as actuary's number on cost of increasing COLA for the retirement system. The Board could increase the COLA 1.7% without a hearing since PERAC has said this is the increase in Social Security, up to 3% a hearing would have to be held. In 2012, the Board increased the COLA base from \$12,000 to \$13,000 with Advisory Council approval. Discussion addressed how an increase from \$13,000 to \$14,000 would be \$30 a year per retiree but member units are still concerned about decreased funding percentages and unfunded liability costs. Some towns are troubled about the Essex Technical High School assessment incorporated into ERRS member unit assessments. The Board members weighed in and agreed that increase from

\$13,000 to \$14,000 for the COLA base could be put off for another year. This will be reported in ERRS newsletter and at Advisory Council's spring meeting.

The Board took a break at 9:31 a.m. and reconvened at 9:33 a.m.

Correspondence

Discussion ensued about correspondence from Michael Sacco 12/23/2014 and 12/30/2014 about summary judgment related to dispatchers' case relative to ERRS changing civilian dispatch classification from Group 2 to Group 1. Also, ERRS has won an appeal that Ronald Patton, part time assessor, filed with DALA about returned ERRS deductions. Susan J. Yaskell noted the error that she notified ERRS General Counsel Michael Sacco about regarding the summary judgment where it should have read Group 2 to Group 1 rather than vice versa which Sacco is redoing and sending to DALA and ERRS.

Executive Director's report

Discussion ensued about goals and objectives for Kostro's 2015 performance review including research for new ERRS business office (i.e., office condominiums in area, possibly former Essex Aggie building except for uncertainty with administration). This will include understanding value of ERRS's existing office space and evaluating whether or not leasing or purchasing of new space should be done. Another goal for the Executive Director is the actuarial appropriation. The Board members will email H. Joseph Maney list of additional goals for Kostro and the Executive Director will work with Maney in preparation for the next Board meeting.

Discussion ensued about how office supplies budget will be less moving forward and be \$10,000 to \$12,000 a year.

Executive Director's report, continued

Update on Fiduciary Insurance Coverage for Prior Board Errors

Discussion was on fiduciary insurance coverage for any potential liability with changes in member service where members are losing benefit. The insurer has asked for documentation of examples relative to list of ERRS cases at DALA with 10 months passed without an answer. ERRS General Counsel Michael Sacco has sent a letter to the insurer to identify if they are going to provide answer before a large document search is done by ERRS.

2015 ERRS Employee Handbook

Language on sick leave use for the 2015 ERRS Employee Handbook is not finalized yet for compliance with referendum question that passed with change to be done by July 1.

Membership Coordinator

Upon a motion by Vincent R. Malgeri, seconded by H. Joseph Maney, the Board voted 5-0 by roll call vote: Kevin A. Merz, yes, Ira S. Singer, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, to appoint Donavin K. Bentley to the position of Membership Coordinator contingent upon the successful completion of a pre-employment physical, at a salary of \$60,000 per year, effective as of February 2, 2015.

Prior Transfers of Reserve Police and Call Fire Service

Upon a motion by Vincent R. Malgeri, seconded by Kevin A. Merz, the Board voted 5-0 by roll call vote: Kevin A. Merz, yes, Ira S. Singer, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, that the Essex Regional Retirement System, upon the payment of the appropriate amount, will accept liability for reserve police and call fire service previously granted at no cost for those members whose accounts have been transferred to another Massachusetts retirement system.

New Business

Update on Essex Aggie (Essex Technical High School) assessment

Discussion ensued about member unit concern about Essex Aggie assessment incorporated into all ERRS member unit assessments since statute states that Essex Aggie should cover its costs. ERRS has sent PERAC a letter on the matter asking for a decision on whether or not High School is responsible for its costs. Also, if PERAC says yes how should ERRS change current member unit assessments.

In response to an ERRS letter, PERAC has agreed that Essex Aggie employees who were members of ERRS would be moved to Salem Retirement Board. PERAC has said that retirees would stay with ERRS and ERRS is responsible for all Essex Aggie members up to June 30, 2014. Discussion addressed language in county legislation that states should Essex Aggie be dissolved or merged then the liability will go with the successor agency. ERRS General Counsel Michael Sacco outlined in his letter that Essex Tech is the successor agency. Another letter from

ERRS to PERAC specifies that ERRS believes clearly that Essex Tech needs to make a contribution to ERRS associated with liability for members and retirees.

Kostro explained that there is no mechanism to assess a unit that is a member of another retirement system. Letters from Sacco and ERRS have asked about using the 3(8)(c) process (over time this would affect unfunded liability) to assess the Salem Retirement Board for cost of Essex Aggie employees and retirees and have Salem Retirement Board assess Essex Tech as a member of their system. If a negative response is received ERRS will go to court or prepare special legislation to address ERRS's ability to make an assessment to Essex Tech directly or indirectly. PERAC has not weighed in on this. Kostro has spoken to PERAC's Jim Lamenzo and everyone agrees that ERRS member units should not have to pick up the cost for members that were not employed by them. The question seems to be how to accomplish this objective. Also, ERRS may not be responsible for liability of Essex Aggie members transferred up until July 1, 2014. PERAC is going to review legislation.

Discussion was on how Essex Aggie still owes ERRS \$375,000 for its FY'15 assessment. Kostro noted that the \$375,000 includes the normal cost, which is the current employees benefit cost, and those employees are now with the Salem Retirement Board. ERRS is seeking Essex Aggie's share of the unfunded liability that is part of the annual appropriation. Also, that the Board had voted to authorize Sacco to provide advice on interpretation of statute and legislation. In addition, if ERRS does not hear from PERAC on this issue especially as it relates to 3(8)(c) it should have Sacco file declaratory judgment to move this process forward. Board members weighed in relative to comments from member units about impact of Essex Aggie assessment on municipal budgets. Ipswich is picking up \$44,000 in its changed assessment which represents one FTE. Discussion addressed how a direct billing mechanism is needed for ERRS relative to Essex Tech as the successor agency to Essex Aggie. Also noted was the impact of deficit in state's building budget in regard to Essex Tech. Discussion ensued with Board in agreement to follow up with PERAC for a response about successor agency, petition for declaratory judgment, and using legislative delegation to start putting legislation in place to fix this assessment situation with Essex Tech. Sacco will be at the Board's next meeting to discuss timing for filing declaratory judgment. Discussion addressed how a concise document could be written by Kostro to explain the Essex Tech assessment situation and impact on ERRS member unit budgets for municipalities and Advisory Council.

Upon a motion by Ira S. Singer, seconded by Vincent R. Malgeri, the Board voted 5-0 by roll call: Kevin A. Merz, yes, Ira S. Singer, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, that ERRS undertake a three-part process to recover the lawful assessment due from the Essex Technical School through following up with PERAC to obtain an opinion on ERRS request/interpretation, to have ERRS general counsel file a declaratory judgment as soon as possible and have preliminary brief available for the Board's review at its February meeting with counsel, file legislation with the delegation that represents ERRS regarding a Special Act which will permanently address the inequity and problem of the Essex Tech assessment.

Realty Associates Fund IX - Proxy vote

Yaskell, yes, to authorize the Vice Chair to execute the proxy vote for Realty Associates Fund IX to re-elect James P. Raisides as Class C Director.
