# Cost of Living Adjustment Public Hearing

Yaskell, yes, to open the public hearing to consider a Cost of Living Adjustment (COLA) of up to 3% to eligible retirees of the Essex Regional Retirement System to be effective as of July 1, 2015.

ERRS had received PERAC's notice that COLA increase for Social Security was 1.7%. ERRS can raise the COLA up to 3% on the first \$13,000 COLA base and Advisory Council has been notified via letter. A comment letter has been received in support of the COLA. The 3% is built into the appropriation.

## **Annual Investment Manager Meetings**

#### Q4 2014 Investment Performance Report

Dahab Associates summarized how ERRS's investments in real estate and private equity did well exceeding PRIT fund performance by 120 basis points, and the success of BlackRock investment in fixed income. The retirement system's investments outside of the PRIT fund are winding down including Boston Millennia. BlackRock is still calling for money. Discussion addressed strengths and weaknesses of PRIT fund.

## Principal Global Advisors Fund

Vance Voss presented performance overview of strong Q4 and year. Since inception return is close to 13% net. Projected equity multiple is 1.5 times. A few assets were sold in 2014 (Denver and Los Angeles) realizing good gains for investors. For the Green Fund II that ERRS has invested in all cash will be returned early 2016.

#### Sentinel Real Estate Fund IV

Robert Bartlett described how multi-family is continuing to perform in secondary and tertiary market with 21.6% return on the fund. This is the final year of the closed end, multi-family fund with all money to be returned prior to end of 2015 (i.e., \$2 million back to ERRS).

# Michael Sacco - Essex Tech Appropriation Options

PERAC has deemed 3(8)(c) process as not appropriate for billing from ERRS to Salem Retirement System for Essex Tech. The options left for ERRS are action in court or legislation. State Representative Brad Hill's office would organize a legislative meeting.

Discussion ensued about how Essex Tech is the successor agency but it is unclear to PERAC to what degree the new Essex Tech bears responsibility for Essex Aggie retirees and unfunded liability. General Counsel Michael Sacco noted that PERAC does not want to get involved in this situation so it has taken the position that there is uncertainty. The letter from PERAC lays groundwork for court or legislative action.

Discussion addressed how ERRS has tried to work out the situation without going to court or legislatively. Also noted was that the legislation was poorly written in regard to successor agency. Essex Aggie was part of ERRS appropriation calculation for fiscal year 2015 with a \$375,000 appropriation share that they did not pay. In FY'16 Essex Aggie was not part of the appropriation calculation for ERRS that was based on one fewer units. ERRS Actuary Larry Stone is determining what the unfunded liability number would be. It has to be decided how a portion of that would be assessed to Essex Tech.

Discussion was on how ERRS would have to notify Legislature what legislation would entail and the associated dollar amount. The member units are looking for Legislation

that would offset the appropriation so they would not have to pay the extra amount resulting from one fewer units paying its cost (i.e., \$41,000 in Ipswich that was not anticipated). Sacco opined that legislation would make new entity (Essex Tech) fulfill the spirit of the legislation to bear the financial responsibility of the retirees of the former entity (Essex Aggie). Discussion will occur with Stone to understand his recommendation on the matter which could possibly be 47 units and Salem Retirement Board as another contributor to appropriation for Essex Tech and amortize the two missed years of payment. Also addressed was how ERRS staff would manage press coverage of the matter relative to court and/or legislative actions it plans to take to resolve situation.
