Late Entry into Membership

Upon a motion by Susan J. Yaskell, seconded by Vincent R. Malgeri, the Board voted 4-0 that Keith A. Hammerbeck shall be permitted late entry into membership of the Essex Regional Retirement System for part-time service beginning on or about October 1, 1973 through July 12, 1979 with the Town of Lynnfield.

Granting Mr. Hammerbeck's late entry into membership was the apparent intent of the retirement board in 1979. However, granting late entry into membership requires a vote of the Board. No Board vote could be found in the meeting minutes of 1979 or early 1980. However, all of the proper documentation exists and this vote confirms the actions taken in 1979. This vote permits Mr. Hammerbeck to continue to contribute retirement deductions at 5% as he has since the Board action in 1979.

Interview Committee - Retirement Counselor

Upon a motion by Ira S. Singer, seconded by Susan J. Yaskell, the Board voted to appoint Vincent R. Malgeri and H. Joseph Maney to the committee to interview selected candidates for the position of Retirement Counselor.

Legal Services RFP - Opening of Bids

Discussion ensued about process for procurement officer to open bids. ERRS received two bids for legal services from its existing attorneys: Michael Sacco and Murphy, Hesse, Toomey and Lehane. Both firms have worked well with ERRS. The bids were open by Executive Officer Charles E. Kostro. July 1, 2015 is the start date for legal agreement.

New Retirement: Peter Nikas

Discussion ensued about whether or not a Section 15 hearing should be held with Ipswich police officer who plead guilty to assault and battery and malicious destruction of property. Sacco referred to Durkin case and how police officers are held to a higher standard when breaking the law where pension was forfeited. The Nikas case requires a judgment call by ERRS Board.

Upon a motion by Ira S. Singer, seconded by Vincent R. Malgeri, the Board voted to take no action on the retirement application of Peter Nikas and to schedule a hearing under MGL Chapter 32, Section 15 for the June 29, 2015 meeting of the Board. Discussion addressed details about how hearing would be managed and witnesses brought in.

Executive Session – Disability Applications

At 9:15 a.m., upon a motion by Vincent R. Malgeri, seconded by Ira S. Singer, the Board voted by roll call: Ira S. Singer, yes, H. Joseph Maney, yes, Vincent R. Malgeri, yes, Susan J. Yaskell, yes, to move to executive session to act on the disability applications of Mark Thomas and Linda Bloom and to return to open session only for the purpose of adjourning the meeting.

The Board returned from Executive Session at 10:41 a.m.

NEW BUSINESS

Discussion ensued about Barbara Sanborn's part time service that is in dispute. She had been told that her part time service was prorated (for time she did not buy) so she expected a year more of service relative to benefit calculation, and she'll have to work

another 11 months before she retires. ERRS sent a letter with apology explaining that retirement system should have vetted this more thoroughly, and provided details on her right to appeal.

Discussion was on clarification mailing for 19 individuals who received errors in statements, and on police incident that occurred at ERRS office.

Cash Disbursement Warrant CD2015.05b

Upon a motion by Ira S. Singer, seconded by Vincent R. Malgeri, the Board voted 4-0 to approve Cash Disbursement Warrant CD2015.05b for \$5,855.

The Board took a break at 11:00 a.m. and reconvened at 11:09 a.m.

Legal Services RFP

Discussion ensued about how the two existing ERRS law firms had submitted bids which met minimum qualifications according to RFP. Murphy, Hesse, Toomey and Lehane will be asked for record of insurance.

Upon a motion by Ira S. Singer, seconded by Vincent R. Malgeri, the Board voted 4-0 that ERRS Board finds both legal services proposals as submitted meet the minimum evaluation criteria contained in the ERRS RFP and that the Board begin to move them to the next level of evaluation to look at comparative evaluation criteria.

Discussion ensued about comparative evaluation criteria including Chapter 32 knowledge, fees, timely service, OML compliance, personnel matters and procurement procedures, ERRS Board meeting attendance, ERRS staff training, represent Board in court and administrative hearings, positive working relationship with consultants, provide timely information on retirement issues, provide interpretation of PERAC and CRAB information. The Board's overall ranking for Sacco law firm as highly advantageous and Murphy, Hesse, Toomey and Lehane as advantageous. The Board reviewed the price proposals (\$250 an hour for Murphy, Hesse, Toomey and Lehane, \$240 an hour for Sacco) and escalators. These were found based on what ERRS is paying now and services provided in line with current contracts. The Board ranked relative to fees Murphy, Hesse, Toomey and Lehane advantageous and Sacco as highly advantageous. Discussion addressed how Katharine Hesse could be invited to an upcoming Board meeting in the fall.

Upon a motion by Ira S. Singer, seconded by Vincent R. Malgeri, the Board voted 4-0 to award two contracts for continuing legal services: one to Murphy, Hesse, Toomey and Lehane for services now being provided and outlined as specialty in RFP, and second to Michael Sacco and his law firm to provide full range of services outlined in RFP, and contracts be approved using draft contracts in RFP, and authorized ERRS Board Chair to sign on behalf of full Board.

Motion to Adjourn

Upon a motion by Vincent R. Malgeri, seconded by Ira S. Singer, the Board voted 4-0 to adjourn the meeting at 11:45 a.m.
