## **Annual Investment Manager Meeting: PRIM Board**

PRIM Executive Director Michael Trotsky summarized expected 4% return for PRIM for year, outlined mission to manage \$62 billion fund and fund \$11 million in unfunded liability. He spoke to cost savings from Project Save relative to \$350 million PRIM annual budget, and top accomplishments at PRIM as well as 6.8% expected return in next five to seven years that is below actuarial return target of 7.9% but could be reached in 30 years since PRIM focuses on not taking risk. The ERRS returns after joining PRIM in 2010 (\$340 million investment) have been above benchmark. ERRS and PRIM are experiencing especially good returns from private equity and real estate. Discussion ensued about ERRS winding down some of its investments outside of PRIM although the

retirement system is still responding to some capital calls, and PRIM's social responsibility strategy (i.e., tobacco and fossil fuels).

Singer, the Board voted at 9:35 a.m. by roll call to move to executive session to act on the disability application of Edward Mitchell and to return to open session. Roll call vote: Ira S. #### **New Business**

#### **Essex Tech assessment**

Discussion ensued about legislative bill for \$700,000 that failed which ERRS had hoped Legislature would approve relative to outstanding assessment payment for Essex Tech's retiree pensions. In addition, the legislation was to direct liability for Essex Tech relative to reallocating debt service. Also mentioned was ERRS's previous discussion to move forward with civil action for declaratory judgment if the legislation failed to determine who is responsible for Essex Tech assessment. The retirement system could ultimately be responsible (allocating amongst ERRS's member units), and if so, this could go back to legislature. Also noted was how communication between ERRS leadership and Essex Tech's on the matter was unsuccessful.

ERRS auditors are working on an assessment number for Essex Tech's share of the retiree pensions and ERRS actuary would determine number including each member unit cost for each year before a complaint is filed. Also, ERRS could speak to State Representatives Brad Hill and Ted Speliotis about the matter. ERRS sent \$1 million to the Salem retirement system for Essex Tech existing employees. ERRS will do a salary survey in September and get it to PERAC in October for FY'17 appropriation. A valuation study will be done in January 2016. Discussion addressed how member units will be aware that there is a third year in which they have been overcharged for retirement benefits due to the outstanding assessment for Essex Tech that has not been paid for.

ERRS General Counsel Michael Sacco opined that a special meeting could be scheduled (August 17) with Hill and other delegates as well as Auditor Jim Powers and ERRS Actuary Larry Stone on the Essex Tech issue.

October 27, 2015 – Counting of ballots and certification of results to PERAC.

October 27, 2015 – First Member term begins for remainder of current term (expires December 1, 2017.)
