Discussion ensued about members with employment agreements and what constitutes regular compensation not including deductions associated with vehicle reimbursement or insurance which is excluded from retirement benefit. This occurred with Ira S. Singer's retirement benefit. ERRS has inquired with PERAC on the matter to ensure the retirement system handled the retirement benefit accurately and consistently compared to other members with similar situations. Also addressed was how ERRS gets collective bargaining agreements and the retirement system should receive employment agreements as well to understand details associated with calculating retirement benefits. ERRS will reach out to member units in regard to employment agreements.

Creditable Service Awards
